Program Cost


Swim and Dive was one of the least expensive programs at MSU supporting (33) women and (29) men in FY 2020.

Given NCAA scholarship limitations, the result was 20 men and 19 women paying MSU tuition.


The teams shared a coaching staff consisting of (1) head coach and (3) assistant coaches which accounted for another \$369,404 in combined program expenses. Remaining operating costs were approximately \$600,000.

From a profit and loss perspective, Swim and Dive ranked 7th and 10th out of the 21 programs.

DID YOU KNOW?

10 of the Big Ten's 12 varsity swim/dive programs use a campus recreation pool. In fact many Power 5 schools utilize intramural and community facilities for varsity training and competitions. That includes Michigan State's wrestling, basketball, tennis, and golf teams.



The proposed indoor aquatics center at Michigan State is long overdue and the Battle team is thrilled to support it. Built correctly with a 50-meter pool, a new natatorium will:

- Bring MSU into National Intramural-Recreational Sports Association (NIRSA) compliance
- Become a revenue source by hosting club, high school, collegiate and national aquatics competitions
- Help recruit top student-athletes to the Spartan athletics family
- Provide ample space for MSU clubs, swim instruction, ROTC, kinesiology classes, East Lansing community and more
- Proper scheduling and lane allocation can accommodate varsity AND community access

WHAT ABOUT IM WEST?

- Sufficient to house varsity swim/dive program until new natatorium is built
- Upgraded in 2017 (structural repairs, renovated locker rooms, new scoreboard
- NCAA regulation at 25 yards more than 50 D1 programs use a 25-yard pool

Competitiveness

The "competitiveness" of the Swimming and Diving program has been repeatedly cited as a primary reason for the program's elimination. Yet, many of Michigan State's non-revenue sports have remained in the bottom third of the Big Ten Conference over the last decade. Some have seen success with coaching changes in the last few years.



Only one Spartan sport was cut. Without warning. Without a coaching change.

Title IX Lawsuit

SWIM & OIZE PARTICIPATION OF THE PARTICIPATION OF

The suit was filed by 11 members of MSU's Women's Swim and Dive team as a result of former Athletic Director Bill Beekman and President Samuel Stanley refusing to engage in any constructive discussions, leaving the women with <u>no alternative</u>.

It is an incredible coincidence that this week marks the 50th anniversary of the groundbreaking federal Title IX law. Despite MSU honoring its women's basketball team on the "Game Changers" wall in the Smith Center, the University is actively fighting against women for equal opportunity in Spartan Athletics

The only thing that the women want is to be able to represent MSU in the pool again and allow future generations the same opportunity. At its core, the suit is about providing an equal number of REAL opportunities for women athletes on campus.

Recent rulings in favor of the plaintiffs have put MSU's reputation on Title IX at further risk, yet MSU continues to commit time and financial resources to contest the suit. Invoices reviewed by BSSD have indicated MSU legal fees are more than \$400,000 to date, and are likely to exceed \$1,000,000 by the time this lengthy process is complete.

MSU should be <u>leading the way</u> in this regard nationally as opposed to looking for loopholes to continue to fly under the radar of the federal law.

Financials & Pledges

\$10.85M in Pledges



The Battle for Spartan Swim and Dive took the initiative to solicit pledges in support of our programs. These pledges were collected without any reasonable target from MSU. Leveraging the Spartan Fund's database of nearly 1,000 living alumni, we are confident these amounts are just the foundation of our support.

- Current pledged commitment base is substantial enough to make MSU Swim and Dive the first program at MSU to realistically target full endowment of all scholarships.
- An estate pledge of \$7,500,000 is included in our totals.
- The programs have a history of strong endowments with existing endowments totalling \$1,222,145 making the women's team 7th and men's team 9th of 21 programs at MSU in terms of revenue from endowments.
- Our team is prepared to work with the Spartan Fund to assist in expanding our model to other Olympic sports at MSU - we know how to mobilize alumni.
- We have multiple alumni who have expressed additional interest in committing to leading match donations with the support of the Spartan Fund - this would total a minimum of \$500,000+ in additional support.
- Program cost is a \$1.2M net positive for the University after the \$2M Athletic Department spend due to a majority of athletes paying tuition.



Just Add Water



Reinstatement of the program to varsity status does not require more than walturning on a hose:

- Board votes to reinstate on June 24
- AD Alan Haller reassigns Kathleen Milloy (actively employed in the Athletic Dept.) on interim basis effective July 1
- Coach Milloy rounds out existing team via transfer portal during July and announces tryouts for the first week of school in August
- BSSD works with Coach Milloy to set up meet schedule for 2022-23
- BSSD works with the Spartan Fund to collect financial pledges during the remainder of 2022
- BSSD works with SVP Vennie Gore and his team to ensure the new H&W aquatic facility will serve MSU for the next 50 years
- 21 varsity team members continue training with the support of MSU

Better Together

A majority of the top college women's swim and dive programs have a corresponding men's team. Of the Top 25 NCAA Division 1 swim and dive programs, 24 have both men's and women's teams. It's vital to reinstate BOTH programs.

Just as Mel Tucker has utilized the transfer portal to fortify his roster, MSU Swimming and Diving can quickly rebuild doing the same.

- Reach out to transfers. There are <u>dozens of</u> <u>transfers reported this spring</u> for swim and dive, meaning many are open to a change.
- Utilize current talent. With 21 former varsity swimmers still on campus after this school year, the foundation is strong and there is ample time to recruit and train for the 2022-23 season.
- **Recruit internationally.** Some of MSU's best finishes in recent memory came from fast foreign talent.

IF YOU BUILD IT ...

Ohio State opened its new aquatic pavilion (a rec department facility) in October 2005. In the four years prior, their B1G finishes were:

2001: M 7th; W 11th 2002: M 7th; W 11th 2003: M 8th; W 9th 2004: M 8th; W 10th

Since 2005, OSU women have finished in the top five 14 times, and this year won their third consecutive B1G title. The men have finished top three in 14 straight years, winning in 2010.

Request for the MSU Trustees:



The BSSD has repeatedly demonstrated its professionalism and dedication to the return of this storied and successful MSU program.

Student-athletes demonstrated their continued commitment to excellence and to MSU, even winning a club national championship.

Despite our efforts, the only result was one meeting held just two weeks ago between four Swim and Dive student-athletes and President Stanley, with no commitment. No parents, alumni, or Trustees were permitted to attend.

The time has come for us to make this very specific request of the Trustees to pass the resolution below to direct reinstatement of the varsity Swimming and Diving program.

Resolution for June 24 Board Meeting:



"The Board has hereby voted and is resolved that the MSU Men's and Women's Swim and Dive teams shall be reinstated to full varsity status, effective 7/1/22.

President Stanley and AD Haller are to work closely with the team members who remain enrolled and the Battle for Spartan Swim and Dive (BSSD) group to identify and solve any remaining issues regarding this reinstatement. Further, President Stanley, AD Haller, or individuals directed by them, will work with the BSSD group to gain the support of the financial commitments to MSU.

President Stanley, AD Haller and BSSD will report back to the Board by 8/1/22 on the results of the reinstatement, in light of the details covered during the collaboration between all parties."

BSSD's Commitment of Support:

- The Battle for Spartan Swim and Dive will aid the Spartan Fund in meeting with key donors and securing the promised \$2.6M+ in endowment funding over the next 5 years per our pledge campaign.
- The estate donor is given an opportunity to discuss their gift with the Spartan Fund directly. NOTE: After a prior meeting between these parties was abruptly canceled earlier this year, this meeting must take place as part of the agreed terms.
- Battle for Spartan Swim and Dive will collaborate with the Spartan Fund to replicate the engagement and endowment model to other MSU sports. Expanding the fundraising abilities of <u>all programs</u> helps alleviate funding pressure on the Athletic Department.
- Former Assistant Head Coach Kathleen Milloy can serve as interim coach, while BSSD engages CSCAA and helps recruit and vet potential permanent head coach candidates.
- BSSD will assist MSU to explore the benefit of a full competition pool, connecting with D-1 universities, Michigan club aquatic programs, the Greater Lansing Sports Authority, and others who can inform on a new aquatic center's revenue and recruiting potential.

Precedent for Reinstatement

IOWA	A federal judge found the Hawkeye's women's swim/dive team had a "fair chance" of winning a Title IX lawsuit after the program was cut along with the men's team as well as men's gymnastics and tennis. Iowa reinstated the women's team in February 2021.
STANFORD	Eleven varsity programs were eliminated in July 2020. After alumni mobilized, raised tens of millions of dollars, and met with the university president, all 11 programs were reinstated in May 2021.
EAST CAROLINA	Members of the women's swim/dive and tennis teams threatened a class-action lawsuit after their programs were cut in May 2020 along with their male counterparts. ECU reversed its decision for the women in January 2021.
DARTMOUTH	Men's and women's swimming along with women's golf were reinstated in January 2021 as part of a settlement after a lawsuit was filed following the July 2020 cuts.
CLEMSON	In April 2021, Clemson reversed its decision to cut the men's track and cross country programs after threat of a Title IX lawsuit - the first time a men's team has been saved under the legislation.
WILLIAM AND MARY	Seven sports were eliminated in September 2020, and one month later the AD resigned after it was revealed she plagiarized portions of the letter announcing the cuts. Three women's teams were reinstated to stave off a Title IX lawsuit, and the remaining four men's programs were brought back in March 2021.
BROWN	After eliminating 11 teams, Brown first brought back men's track and cross country, then reinstated women's equestrian and fencing in order to comply with Title IX.
LASALLE	In September 2020, seven teams were cut, though LaSalle administration said it would reconsider the decision if fundraising goals were met. The men's swim team was brought back in May 2021 after exceeding its goal. LaSalle also agreed to reinstate the women's team if a review indicates it's out of Title IX compliance.
BOWLING GREEN	After alumni and donors pledged \$1.5M, BGSU brought back the baseball team less than one month after it was cut in May 2020.



Financial Improvements at MSU

Massive Big Ten media deal on the horizon	The B1G Conference is negotiating a new media rights deal worth a record-setting \$1 billion per season, starting in 2023. MSU's take is projected to be an additional \$25+M annually.
Ishbia major donation	MSU alum Mat Ishbia's record \$32M donation goes to expanding Spartan Athletics facilities. Ishbia designated \$8M for an MSU Athletics Excellence Fund to "provide flexible, unrestricted resources that can address needs and take advantage of new opportunities as they arise."
\$1M for Olympic sports	Michael Williams donated \$1 million to benefit 10 sport programs, providing funds for recruiting, technology, travel, and health and wellness for W Basketball, M/W Cross Country & Track, M/W Tennis, Volleyball and Wrestling
Partnership with Caesars Sportsbook	A multi-year partnership worth an estimated \$9,000,000 makes Caesars Sportsbook the official betting partner of MSU Athletics. It includes new broadcast and digital visuals, upgrades premium seating and an outdoor tailgating area beginning this fall.
Five-year deal with Rocket Mortgage	The extension of MSU's ongoing deal with Dan Gilbert's company was called a "presenting sponsorship of the MSU Men's Basketball season," with additional funds going to women's basketball, hockey and football.
Couple donates \$10M for Izzo facility	Greg and Dawn Williams gave \$10M for the expansion of the Tom Izzo Football Building, including a modern weight room and mental health and wellness area.
Investment performance and federal cash infusion	MSU's investment funds have performed exceedingly well since October of 2020, which, along with infusions of cash from the federal government's various COVID-related stimulus programs, have helped MSU's financial position tremendously.





APPENDIX - Barriers to Reinstatement?

The following pages outline the issues that we have been made aware of from the original letter announcing the cut, discussions with various Trustees, and the student-athletes' meeting recently with President Stanley.

"Swim and Dive is the most expensive sport"

- Data presented above clearly shows that this is not the case, with Swim and Dive having one
 of the lowest "cost per athlete" ratios among varsity sports.
- Construction of a pool is indeed a capital project, but one that MSU is undertaking with certainty and benefits the <u>entire</u> university community.
- It's reported that Wrestling will move out of IM West to the new H&W center, to the tune of \$10M - \$12M paid by the Athletic Department - a significant investment by Athletics for a facility with limited value to the broader MSU community.
- Swimming moves over to the H&W center at <u>\$0 in marginal capital cost</u> to the Athletic Department, assuming the aquatics center is designed properly to serve the MSU community for the next 50 years, which would include stands and locker rooms for broader use.
- Athletics pays a usage fee for use of the H&W center for Swimming/Diving. In the Big Ten, the known average pool usage fees paid by athletic departments is \$186,750 annually. It becomes a <u>residual income source for MSU with nominal impacts to Athletics</u>.

"There is no funding for the new aquatics center yet"



- This is semantics. It is widely known that the new H&W center will include aquatics an Olympic-sized
 50M pool, which is currently being planned for and designed.
- Expected cost of this pool is ~\$30M. The current student rec fee of \$260 per year does not completely fund this portion of the Health & Wellness Center.
- If the rec fee is raised to just \$300 per year, that would solve the funding gap. Residual rental revenue from Swim/Dive & Athletics would add ~\$200,000 annually.
- Alternatively, MSU could seek naming rights on the facility.
- MSU must build this, due to not meeting NIRSA standards and aging pools on campus that are beyond their useful lives and are expensive to operate and maintain.
- MSU's desire to demolish IM West would leave it with no pool for 50,000 students and even more faculty and staff, thus it CANNOT demolish IM West until building this new aquatics facility.
- The pool on its own solves the "stated" original reason for cutting this program. IM West is fine in the interim period to house the team as it has the last 60+ years.

"A varsity team can't use a rec-funded facility"

- In the Big Ten, only the University of Michigan and Nebraska have a varsity-only facility. All others train and compete in recreation pools.
- A financial arrangement between Recreation and the Athletic Department secures necessary pool access, at a reasonable fee.
- Other MSU sports use Rec and RHS facilities, including Basketball (Breslin Student Events Center), Wrestling (IM West), M/W Tennis (MSU Tennis Center), and M/W Golf (Forest Akers).
- Confirming equitable access for students, clubs, and varsity teams to the pool is not an issue. Proper lane allocation and scheduling mean for a busy (but profitable) aquatic center, operating from 5 a.m. to 10 p.m.

"Swim and Dive funding has been allocated to other sports already"

- SWIM & OILING
- The stated reason for the cut in 2020 was the pool facility, NOT reallocation of Athletic Department dollars. In fact, the official PR signed by Bill Beekman and President Stanley specifically downplays the financial impact
- MSU is still paying for scholarships for the existing student-athletes, so total reallocation of the \$2.1M in operating costs is not possible.
- BSSD can help offset remaining costs for the upcoming season, which will be <u>much</u> lower than average total costs.
- In addition, we refer you to the "Financial Improvements" slide. The new Big Ten TV contract should provide \$25M - \$30M in incremental revenue, one of many funding solutions available.
- We would like to understand <u>exactly</u> where the money has been reallocated to
 if this is the case.
- This appears to be another case of "moving the goalposts," and one that BSSD is prepared to clear.

"It is a changing landscape in college athletics with NIL & Rewards for Academic Performance"

- Our analysis is focused on money spent by MSU Athletics. Name, Image, Likeness (NIL) payments would not impact this budget.
- If MSU considers paying its student-athletes a reward for academic performance, as approved by the NCAA in August 2020, it would have a maximum exposure of \$5,980 per athlete.
- Based on the last tally of +/- 700 student-athletes, that would be a <u>maximum</u> payout of \$4.2M. This tally would likely be lower since it is to be expected that not all athletes would meet the bonus criteria.
- This amount is covered by the incremental funds generated by the Athletics Department, as outlined in this presentation, <u>funds which did not exist on 10/22/20</u> the date of Swimming and Diving's elimination.

"Swim and dive has been the least competitive sport at MSU for the last 25 years."

- Mediocre performances have been recorded by many Spartan programs over the last decade (see Competitiveness slide). Recent coaching changes have been made, some with an impact. For example, under a new coach, W Soccer rose in the Big Ten standings from 13th in 2021 to 4th last season.
- MSU did it not make a coaching change with the Swimming and Diving program in 19 years. Matt Gianiodis started as head coach in 2002 and was one of MSU's longest serving coaches when the program was cut.
- According to sources, <u>Coach G's instructions were to recruit high-achieving students, run a clean program, and earn top grades</u>.
- If performance was an issue, why were no new directives given to the MSU swim and dive coaches? Why was a coaching change not made (as is happening right now in other sports)?
- To improve competitiveness immediately, a coach <u>only needs to change the profile of who</u>
 is recruited. Faster swimmers vs. top students, who score more points at dual meets and
 the Big Ten championships, and qualify for NCAAs.
- In the 1990s, the Men's team recruited one of the top classes in the country, bolstered by foreign Olympic athletes and four-year athletes brought in for speed vs. academics. The result was multiple Top 25 finishes at the NCAA Championships, All-American performances, and a competitive Big Ten team.



- Just months after the October 22, 2020 announcement, Battle for Spartan Swim and Dive launched a pledge campaign. Without any commitment from MSU, our alumni, parents, and supporters offered more than \$1.13M in pledges toward reinstatement
- Combined with existing endowments, that was \$2.35M committed in less than a year.
- Then, an anonymous donor offered \$7.5M of their estate to MSU Swim and Dive. A second donor offered \$200K per year over five years, for a total donation of \$8.5M.
- A meeting was scheduled this spring with the Spartan Fund between the anonymous donor and Spartan Fund Senior Director of Development Rebecca Surian to assess the offer and review the terms of the donation.
- Only two hours prior to the scheduled meeting, <u>Surian unexpectedly cancelled, saying</u> "we can't accept money for programs that no longer exist."
- The donors stand ready to meet and verify the legitimacy of their offer. MSU leaders
 must demand this meeting so we can move forward with the proposal.
